As mayor I do direct Village employees. I have built a up a mutual respect with our employees that has not existed for a long time. Trustees have a responsibility to report problems to the respective departments and discuss the facts before making accusations. Just as Trustee Warner does with the grass complaints.

Just picking up everything is not a responsible approach. It encourages people to just leave messes for the street department to clean it up. If we pick up everything, we will have to raise the tipping fees. Some people take in garbage from somewhere else and we residents are paying for this extra garbage. Our Fire Marshall has requested to re convene the garbage committee to work on garbage problems but received no response.

People who contact me are more concerned with security, safety, and saving on their taxes - which is where I choose to concentrate my time. My secretary is the one who handles all clean energy programs and grants. We need to take advantage of all these programs while they are available, instead of having to pay a lot more money in the future when things are mandatory by the State.

I went to a Town of Union meeting. They are paying \$89,120. to repair the Argonne Street Pump station. I want to thank the Town of Union for their generously.

Thank you to Assemblywoman Lupardo for a \$250,000 grant to our fire department. She also acquired a grant for our police department. She is amazing. No other politician has done so much for us here in the Village, and we want her to know how much we appreciate all her hard work. The Town of Union and the school use NY alerts for emergency emails and texts to alert residents of emergencies. Our media service is now working with us to set up this free service for our residents.

I was contacted to participate in a movie to be made about Endicott history. 'Which Way EJ?'. I have asked our Village Historian, Suzanne Meredith, to talk about this history. This will be shot at our museum.

Am in discussion with the Methodist Church on McKinley. With declining membership, they plan on closing next year. Among the ideas for the building is a day care center. More people will go to work if they have a safe and affordable day care for their children.

The State announced they will have the approved projects for the 10-million-dollar DRI by the end of the month.

Jason Garner was at Endicott Proud. He had a lot to report. The Binghamton airport is getting 40 million dollars to upgrade the terminal, direct air service to Florida, putting 31/2 million dollars for Grippen Park – artificial turf for sports, an outdoor ice rink for the winter, a second floor to watch games, a snack area, and more. #### LOCAL LAW NO. 14 OF THE YEAR 2022

# A LOCAL LAW AMENDING CHAPTER 235 OF THE VEHICLE AND TRAFFIC LAW TO INCREASE THE SPEED LIMIT ON A PORTION OF MCKINLEY AVENUE

Be it enacted by the Board of Trustees of the Village of Endicott as follows:

Section 1. Section 235-62, Schedule II, of the Village Code shall hereby be amended by adding the following:

#### Section 2. Remainder

Except as hereinabove amended, the remainder of the Village Code of the Village of Endicott shall remain in full force and effect.

#### Section 3. Separability

The provisions of this Local Law are separable and if any provision, clause, sentence, subsection, word or part thereof is held illegal, invalid, unconstitutional, or inapplicable to any person or circumstance, such illegality, invalidity or unconstitutionality, or inapplicability shall not affect or impair any of the remaining provisions, clauses, sentences, subsections, words, or parts of this local law or their application to other persons or circumstances. It is hereby declared to be the legislative intent that this local law would have been adopted if such illegal, invalid, or unconstitutional provision, clause, sentence, subsection, word or part had not been included therein, and as if such person or circumstance, to which the local law or part thereof is held inapplicable, had been specifically exempt therefrom.

#### Section 4. Effective Date

This Local Law shall take effect immediately upon filing with the New York State Secretary of State in accordance with Section 27 of the Municipal Home Rule Law.

### MAYOR'S ANNONCEMENTS, OCTOBER 17, 2022:

As mayor I do direct Village employees. I have built a up a mutual respect with our employees that has not existed for a long time. Trustees have a responsibility to report problems to the respective departments and discuss the facts before making accusations. Just as Trustee Warner does with the grass complaints. Just because rules have been ignored in the past, or some people do not feel they have to obey the rules, does not make them nonexistent. Just picking up everything is not a responsible approach, and it did not help the look of the Village. Allowing people to do whatever they want is easier for us politicians, but it is not fair to our street workers or the rest of the Village residents who are trying to follow the rules. It encourages people to just leave messes for the street department to clean it up. It takes time away from the street department employees to do other jobs — like filing potholes!

People are putting out three cans, waiting for the garbage truck to go by and pick it up, then they refill the cans and call and report their garbage was not picked up! Like W. Main Street and South Roosevelt. Or they wait for the truck and throw their bags into the truck themselves, like N. Roosevelt. (See pictures.) They have a lot of garbage for a one family house. Either they have many families living there, or they take in garbage from somewhere else and we residents are paying for this extra garbage. See Lynn in the Street Department for proof.

Our street supervisor is vigilant regarding the throwing of cans. He has addressed this with the pickers. But we cannot control the wind that moves cans.

Our Fire Marshall has requested to re convene the garbage committee to work on garbage problems but received no response. We need to decide if we are going to enforce the rules we have, make some changes, or just throw away the rule book. We cannot just pick and choose which rules we feel like enforcing. If we pick up everything, we will have to raise the tipping fees.

People who contact me are more concerned with security, safety, and saving on their taxes - which is where I choose to concentrate my time. My secretary is the one who handles all clean energy programs and grants. We need to take advantage of all these programs while they are available, instead of having to pay a lot more money in the future when things are mandatory.
