3. Mayor's 1st Comments

Mayor Jackson clarified she is pro-business and welcomes Byrne dairy if all goes through. Stated BAE and Imperium3 are well invested in the Village. Dick's Open is celebrating their 50th. Anniversary this year. Attended the Water Board meeting and detailed the highlights. The carousel should be repaired by the 1st of June. The Village does intend to participate in the Ride the Carousel event. She stated Gorick won the bid for the demolition of 108 Roosevelt Ave.

MAYOR'S ANNOUCEMENTS, APRIL 19, 2021

I am in favor of the Byrne Dairy project. We are working on amending the cigarette law for any new businesses that come to the Village.

The developer received money to take down the former Endicott Inn but did not rebuild due to the Agency not giving our PILOTS to hotel projects.

I was against changing the zoning to add industrial zoning to the residential zoned area of Main street in the Village. We have a large enough industrial zoned area. My viewpoint in last week's paper was factual. I have always been against any deviated PILOTS. Standard PILOTS are available, I do support this apartment complex, just not a deviated PILO T that only benefits the developer and not the Village residents.

Sungeel has been gone for an exceptionally long time. And no lawsuit went anywhere. It is time for your guys to get over it. Bringing this facility into the conversation is only for a smoke screen to hide the huge tax break they want to give this developer.

This is a small project compared to Imperium and BAE. And, these companies offer a lot of jobs, and people on the Avenue to support our businesses

We have a lot more going on in the Village. I prefer to spend my time on these new projects.

The SEPP Group is proposing an apartment complex, for singles and couples with medium income, on Washington Avenue. This will be a fantastic boost for both the Avenue and he Village.

Although Sungeel has been gone for many months, they have finally closed their air permit. But we do have many new companies and sub-contractors looking to come to the Village. And perhaps these new employees will rent apartments at the new SEPP project.

Dicks open will be celebrating their 50th year anniversary this year. While the crowds will be more limited than usual, it will be great to have them open and have a concert this year!

Water board meeting: Hayes Avenue pump station project is projected to be completed by July 1st. Pine Street water tank is drained and ready for inside painting. Test wells being drilled at Argone Street and behind the Community Center will be sending out samples, to be returned by the middle of May to see if either one can be used for a Village well. The new apartment complex at Sky island has many projects to complete like a pump station, hydrant, and connections. These projects will be funded by the developer, with the Village taking over maintenance after one year. Many other spring and summer projects like the water main for smith Drive, etc.

Our carousel is still being put back together. We hope to have it done by the first part of June. We do intend to participate I the 'Ride the Carousel' event. We just need to find out what the requirements are regarding COVID rules.

Goric won the bid to demolish 108 Roosevelt Avenue. They legislature will vote on this tomorrow, and demolition will take place in about 10 days.

VILLAGE OF ENDICOTT

RESOLUTION R#25-2021

At a meeting of the Board of Trustees of the Village of Endicott, held on the 3rd day of May, 2021, the following resolution was offered by Trustee R. Ted Warner and seconded by Trustee Burlingame.

WHEREAS, pursuant to NYS Village Law § 4-412(1), the Village Board has authority to manage Village properties; and

WHEREAS, the Village Board hereby finds it in the best interests of the public to adopt and implement a policy to protect trees located on certain Village properties from unnecessary removal, cut down or debranching, fully or partially, within the Village of Endicott; and

NOW, THEREFORE, BE IT RESOLVED, that the Village Board hereby adopts and implements a policy whereby no tree or trees may be removed, or partially or fully cut down and/or debranched, that are located on the lands of the Endicott Village Offices, Endicott Visitor Center, George F. Johnson Memorial Library, Endicott Fire Department, Endicott Police Department, Mersereau Park, George W. Johnson Park, or Endicott Veterans Memorial Park, without such action first being approved by a majority vote of the Village Board of Trustees; and

BE IT FURTHER RESOLVED, that notwithstanding the foregoing, trees located on the aforementioned properties may be removed, or partially or fully cut down or debranched, upon a determination by one or more of these, and only these, Village officials: the Village Manager, a Village Department Head or an Acting Village Department Head, that an emergency condition exists requiring such removal, or cutting down, or debranching, provided that such emergency condition is documented by the individual making the determination and such documentation shall be provided to each Village Board member within five days. The removal, cut down or debranching shall be performed in a manner that disturbs or harms the least amount of the tree or trees necessary to alleviate the emergency condition; and

BE IT FURTHER RESOLVED, that nothing herein shall limit or otherwise restrict Village employees, officials or contractors from removing and disposing of trees, branches or parts of trees that have fallen to the ground due to acts of nature or vandalism; and

BE IT FURTHER RESOLVED, that within forty eight (48) hours of adoption of this Resolution, the Village Manager shall provide a copy of this Resolution to each and every Department Head and this Resolution shall be retained by the Department Heads in their official records; and

BE IT FURTHER RESOLVED that this Resolution shall take effect immediately.
