3. Mayor Announcements

Since the Trustees would like the office next to my secretary, Anthony and I decided to let the new clerk and intern use the conference room. This is a win for everyone.

We won the 10 million dollar grant from the DRI. The state is in charge, and will have a kick off meeting soon.

Celebrated Marcia, secretary for the firemen and street department, and firemen Worden and Stokes retirement party.

Another presentation of Washington Avenue designs. We plan on starting construction in the spring.

Anthony and I talked to the Broome County Arts Council and some companies involved about the art park.

Fitness equipment for Endicott and Jonson City has arrived in storage at our central garage. Town of Union is providing this for us.

With new companies and business coming to Endicott, we are talking to the owner of the former Endicott Inn property about a high end hotel.

Attended a Triple Cities Pilots dinner. We discussed upgrades to the airport as well as a possible longer runway to accommodate larger planes – maybe even jets

I appreciate Nick helping with the Chamber of commerce initiative of community events with the North side. Now that Eileen is gone, Endicott Proud has offered to help with events. We also need help with an ethic festival I heard about from downstate trustees at a conference.

Many water department projects are finishing up. We will be purchasing residential and commercial water meters and date collection systems. Water rates will need to be raised.

At a parking committee meeting we discussed four additions to our code 235 for streets. We will revisit this at our next board meeting.

Attended the swearing in for three new police officers, Parks, Clark, and Lewis. Welcome to our family!

Deputy Mayor:

A deputy mayor is not a state mandated office and I am under no legal obligation to have one. Many mayors before me only chose someone to do this if they were to be out of town for a meeting. With zoom I can now run a meeting while on vacation.

My main concern is managing our department heads during a n emergency. Our village manager already does this now, and it is in his contract. According to our emergency plan, the order is the mayor, deputy mayor if there is one, then the Village manager. Since Anthony is not political, knows the department heads, knows how the Village is run, and is at the Municipal building every day – he is the perfect one to manage in case of any emergency anyway. We must amend his contract to be more specific in this area so there is no question as to who will be in charge. The mayor or deputy mayor can still call for a state of emergency, etc. We need to keep politics away from emergencies.

I am now appointing Trustee Nick Burlingame as my deputy mayor. I appreciate all of the work he has done for the community on the North side, his understanding of NYCOM and rules, etc. Welcome Deputy Mayor Burlingame.
