We will be sticking to the agenda tonight as our Village Attorney reminded us at the last meeting.

I have a lot to report because there is a lot going on in the Village. Luckily, I have my secretary to help me on my projects.

My secretary is concentrating on our many clean energy grants and projects. We have almost cleared all the red tape to finally get an intern to help with these projects.

Attended a news conference at Binghamton University where Dr. Whittingham announced he is in competition for a 75-million-dollar grant for research and development. We hope he will put this facility in Endicott to complement our Imperium 3 manufacturing facility.

Attended a work fair. We have many more positions open than we do applicants! We are working on ways to get people to come to Endicott for these jobs.

Klaw Industries – glass recycling – is now up in West Binghamton. Their 'slag' ingredient to be added to concrete is more environmentally friendly and stronger that the cement additive. With glass making up 40 % of our recycling, this could be a tremendous help to our escalating \$300,000 increased recycling costs since the Taylor garbage fire.

Our Firemen's Union is working on a contract to take over first alarm response for hose or barn fires in the Town of Maine.

Delta Engineering met with our department heads to modify designs for the Avenue Revitalization.

I am now the president of the Association of Towns and Villages. Our next meeting is planned for March 24th. Place to be determined.

Attended a Binghamton Metropolitan Transit System Committee Meeting. They are conducting a study of our Industrial Blvd, to the airport to see what upgrades we need there. We anticipate an increase in traffic to and from the airport.

Went to a Chamber of Commerce breakfast. They work on legislation to help businesses and municipalities. We discussed unemployment costs for small businesses and the people of not finding enough employees to support our companies.

Had a meeting with the DRI over the plans for our next grant projects. People in my group would like to see Endicott come back to the glory days of industry and manufacturing. I need to better get out the work of the companies we now have in Endicott.

Spoke with a newspaper reporter regarding Byrne Dairy opening soon. It is proof that the outside world can see the new potential on our Village.

Met with our Airport Manager and an Engineer for McFarland and Johnson about the grant we have for the airport. We need to tackle the obstructions to runway 21 with trees that are hindering airport landings at night.

I want to thank Deputy Mayor Burlingame for representing the Village at the Recognition Ceremony for two of our brave firemen.

4. Trustees

Burlingame-Thoughts and prayers to the residents at 208 N Roosevelt Ave due to a recent fire. Commented on a photo of the new EPAC digital sign, looks great. Broome County landfill is offering a free drop-off of household hazardous waste and electronics on 3/12/2022 and 3/26/2022 from 7:30am-11:30am. On Thursday, there was a scheduled workshop for the DRI, he encourages input from residents. He attended the Broome County Firefighters Association meeting where they awarded the William Grace Firefighter of the year-2 of our Village firemen received this prestigious honor, Inspector Matt Griswold & Firefighter Chris Samson. He commented on the proposed Maine Fire District Contract Proposal and feels it needs to be a mutually beneficial agreement between the Maine Fire District and the Village of Endicott in order for this to be successful. He added that Little Italy is working on a Easter Event at the GWJ Northside Park. More details to come. Comments on the request from last December to become a TreeCity USA.

Dorner-stated the next few weeks he will be working with the Village Manager on the Village budget. Comments re: placement of the new well and suggested amending the recycling law with our Village Attorney in allowing cleaner recycling companies to come to Endicott. Warner-Questions to the Mayor-he would like to place his name on the committee for the Maine Contract. He asked the Mayor about a topic that she was going to place on the next board meeting, the Mayor did not recall at this time. he asked the Mayor if the project for the Airport will be brought up and his concerns re: the cost; he questioned the rumors as to Phoenix Investors/Huron does not want the steam plant? The Mayor stated she is not aware of this. He asked on the status of the communications for filing and as to placing them on the website. The Mayor stated this has already been done. He commented on the powerpoint for the Fitness Park as well as the marquee at EPAC. The Mayor asked Trustee Warner if he had any comments re: the busing situation. He commented on the interest of redirecting this route. He stated they are in discussions.

Wright- he attended the DRI Public Workshop and is extending his focus to bettering the image of Endicott, especially in the park department.

5. Village Manager

He spoke of the DRI Public Workshop in which there will be 3 more scheduled workshops and hoping to have the next meeting in person at the Village Municipal building. Submissions need to be turned in by July. The other project he is working on is the Greater Binghamton Funds Project which is the Washington Ave and surrounding areas revitalization. This includes streetscapes. He attended a meeting on the ArtPark in which more conversations are necessary. He attended a BMTS Study Planning Committee meeting re: traffic light projects. Had some Union meetings re: our street and parks departments. He is working on a debt refinancing for the Village outstanding general fund and wastewater department debt that we have outstanding bonds on. He spoke with Rotary re: the band organ that they own. They would like to move this to the GWJ Park Carousel this year. Commented on the Federal Bipartisan Infrastructure law that will be enacted soon with some of the monies going to the Airport in which the Village would be responsible for 5%.

6. Attorney for the Village

Responded to Trustee Warner re: the communications for filing being placed on the website for future meetings. (side note: this has already been completed beginning with today's board meeting) He stated the authority to do have remote meetings ends on 3/16/2022. If the Governor extends this, it may affect our next meeting but if not, our next board meeting on 3/21/2022 will likely be in person meetings.

The Greater Binghamton fund has included an Art Park as part of the revitalization plan of Washington Avenue – to entice people to come to Endicott.
