3. Mayor's Announcements

Attended a police Reform committee meeting on Tuesday, March 2nd. Everyone was incredibly supportive or the fantastic job our Endicott Police department interacts with the Village residents.

Housing visions is now taking applications for the affordable housing project at the former HBE school property at 23 Jackson Avenue in Endicott. Available is 43 1-bedroom apartments costing \$540.to \$750 per month. 18 2-bedroom apartments costing \$710. a month. Some of these apartments are handicap accessible, and some for hearing impaired. Housing.

Talked to leaders in clean energy technology. Town Hall meetings are being planned to educate the community on the facts regarding clean energy and battery technology. There are some engineers coming here to work at Imperium 3 who will be looking for a place to stay. Imperium plans on recruiting engineering students from the graduation class at Binghamton University.. As well as a couple more companies that may consider coming to the Huron campus. That is why this reputation repair is so important.

I spoke with Stacy Duncan from the Agency. They have offered to help on several projects. One is to offer help to clean up the former forging works for a potential business. They will work with the DEC on the cost so the new company will not be charged for this expense. We have had some interest on the former Kmart site with two potential parties. We are working on a plan to do a phase two with the DEC and use our restore New York grant for demolition and turn this site into a brown field. Also discussed solar arrays for lower income property owners to offset utility costs. There is a program for renewable energy as well. This may go along with our Wastewater solar farm project. We have ideas we will be bringing to the Agency soon for Little Italy properties.

We dedicated our new fire truck. The 60-foot cell tower, that was approved by the Planning Board in December of 2019, is now starting construction. The Village board was not in favor of this tower, so we should work on regulations for this kind of structure.

My mayor advisory committee has been moving ahead. When we get our ideas organized, we will bring them to Delta who is also organizing the other Washington Avenue committee ideas and they will bring all these ideas to the public for community input. Our other Washington Avenue committee met this week for the first time. We had many preliminary department budget meetings. My secretary is continuing to work on grants. We just received a couple new ones we can apply for. I went to Nick's refuse meeting. We got another notice from NYCOM referring to our money for Albany. This may come in the form of our CDBG allocations. Byrne Dairy has expressed interest in the former Friendly's building. I will be meeting our new police recruits this week.

Went to visit Compassionate care on Main Street in Endicott. This agency helps people with traumatic brain injuries acclimate into society. I will provide the Trustees with an update on the happenings of the Village every Friday.

4. Trustees' Reports

Burlingame-He has been working on garbage related issues and solutions. Attended a Refuse Advisory Meeting last Thursday. He has been attending a Diversity Inclusion class at BU At the board meeting on 4/5, they will be adding (2) people to the Parks Advisory Commission. Although no date has been set, they are planning a meeting next month and will inform everyone when a date has been set. He has been in discussion with a few people of starting a welcoming committee for new residents, possibly creating a flyer or a handout with useful community information. This is in an idea stage only.

Dorner-Has been attending the budget sessions with VOE department heads. The Press and Sun Bulletin has contacted him for an interview re: 10-point plan.

Konecny-Apple Fest applications have been sent out and working on the Porch Fest Event **Warner**-he briefly discussed their 10-point plan and emphasized this not a Village plan but a Warner/Dorner & Burlingame plan. He is working on a plan/motion/resolution so that another issue such as tree removals from village properties cannot happen again. He asked the Mayor if she can inform the Board of Trustees about certain things that are happening such as: Kmart Plaza/ Endicott Forging Projects.

He made a motion that any meetings of any Endicott legislative committees and any Endicott board of advisory committees shall be made available to the committee members and or to the public on Zoom upon the verbal, written or email request by any 1 person to the Village Manager at least 5 hours prior to Village board meetings and by majority vote of each legislative committee or each board advisory committee or by the Village board, the public may be allowed to speak for 3 minutes each, during any of these meetings if the boards so vote.

5. Attorney Report

Reported on being more aggressive in the Code department and the violations. He is working on and making changes on the Charter Communications Agreement Renewal. Time Warner use to provide free cable and internet service to Municipalities under the old agreement but Charter Communications no longer honors this so he is negotiating for free service of cable and internet.

The Lead Agency notice for the Skye View Project was sent out after the last meeting and the 30 day period for any involved agency is coming up soon. No responses as of yet. He is working on a Social Media Policy. Standards may range between the Village departments so he is trying to find a way to meld it all together.

6. Manager Report

Budget sessions are going well, he reminded all re: the Village tax cap # is 1.31% (inflation being lower than the 2% tax cap). He attended the NYS Main St Grant meeting with its and committee and consultants, (4) projects have been given the ok to start and there is still some more funding available so they will be reaching out to applicants who initially were interested and others who have a potential target in that area. He attended the Washington Ave committee meeting. He attended the Refuse Commission meeting as well as a webinar re: Cyber Insurance Policies. CDBG projects include fencing in the Northside Park, the bid is out for the upper playground and the Oak Hill/Odell Ave Street Project is being looked at. Trustee Dorner asked a few questions re: who runs this and the ramifications of the tax cap. Bates stated this was run by the State legislature stating municipalities have to stay under the 2%. If you do go over the 2%, a local law needs to be passed and approved by the board.
