Mayor Jackson stated that information or mail addressed to the Board is sent to them, she does not have any influence over Trustee emails. She stated she agrees with the Altura Project, she does not care for the deviated PILOT. She feels that if they cannot afford to finance their own project then maybe they should rethink their project.

Trustee Warner asked if the Village is better off receiving 50k in taxes over the next 20 years or do you feel like it's better to receive 5.2 million? Mayor Jackson responded that it would depend on how much we have to spend out to get the 5.2 million. She suggested the developer going for a standard PILOT and she would be on board, not a deviated one.

4. Trustees' Reports

Trustee Dorner-Met with Chris Pelto and they have a few leads on prospective tenants Trustee Burlingame- he has attended several Village budget meetings. He attended the unveiling of the Wurlitzer Band Organ at the Rotary meeting. He stated that it has come to his attention that Trustees are not receiving communications and mail that is addressed to the Mayor and the Village Board and asked if they could begin to receive these copies that is addressed to them. Trustee Warner- Trustee Warner asked if the Mayor was "watching" the meeting only and just not participating? The Rotary Club celebrated a 100th Anniversary and they unveiled a Wurlitzer Band Organ. They plan on rotating the band organ between the (3) Carousels.

He commented on a vacancy for the Planning board, position #1 which would continue through this year. The Zoning board also has a vacancy, position #3 which would extend through 2023. There are (2) openings for alternates on the Planning board and (1) opening on the Zoning board for an alternate.

Trustee Warner spoke on summarizing the Mayor's announcements and the Mayor's report that was to be given to the Trustees on Fridays.

He updated those on Zoom, re: details on the Altura Project and the proposed PILOT

Attorney McKertich stated the Social Media Policy that the Board requested is underway and he should have a draft of this by the next board meeting. The Planning board did meet in March and reviewed the zoning aspect of the Altura Project and they did recommend approval of rezoning. They are still in review of the preliminary development and communications and updates of the plan that has been sent to the applicant and his engineer.

He asked for authorization to dismiss the case for Wolozyn, the case challenging the Recycling Law and feels it is time to dismiss the case. He updated everyone on information re: regulations to the Tobacco Retail License.

Delta was included as well. He received the fiscal stress report from the State, he stated that the Village scored 9.6, which is in the no designation category for the fiscal year through May2020. He feels per these calculations, the Village is in pretty good shape.
