3. Mayor's 1st Comments

I have contacted Broome County Emergency Services to help with our emergency alerts. They received over 400,000 calls last year with a minimum staff. We will continue to utilize our social media and Facebook accounts to pass on alerts.

My secretary has been working diligently for the last year on our NYSERDA grant. Tonight, we will vote on designating the Village as a Clean Energy area. This is to complete one of our steps in working toward many thousands of dollars in more grants for our Village. With this benchmark, we will receive our first \$5,000.

We have spoken with Jason Shaw regarding placing Village tax information on the Broome County tax lookup. The demolition of 108 Roosevelt went well. Another new restaurant opened in Endicott, Junoz, on the corner of Liberty and North Street. American /Italian homemade food. The horses are being placed on the carousel. Some more work needs to be done on aligning the gears. Hopefully, we can open the carousel the first part of June.

The pool is being filled. We are in need of more lifeguards. My secretary, Alicia, is now the secretary for the Planning and Zoning boards. I attended the tapping out ceremony for Chuck Hoffman retiring from our police department. He will be greatly missed! Attended a zoom meeting with Jason Garnar. He expects the State to be opened by May 19th.

Warner- Question to the Mayor's comment in relation to the Altura PILOT and how she came up with how this project would cost the tax payers \$32 million. She answered that according to the developer's plan that in the year 2023, if he was paying the correct amount, she multiplied the assessed total by 23. He then asked the Mayor as to what was the delay into getting the Boil Water Advisory message out to the public. She commented that there were several reasons. From here on out, when there is pressure dropped in the water system, we will issue an advisory. Emergency Services are now on board and will be made available to the public. He feels that Facebook should not be the main source of information. He noted there are systems that can notify everyone via text or email. Commented on not receiving mail addressed or information to the Mayor and the Board. Mayor Jackson responded saying placing notices on Facebook was an emergency services request. As for no emails from her, she replied she has no involvement in who receives the emails.

5. Village Manager Report

Village Manager Bates met with Jason Shaw re: placing Village taxes online. He attended the demolition at 108 Roosevelt Ave. He mentioned an Art Park, one of the projects in the Greater Binghamton Fund and will have more information at a later time. Attended a Washington Ave meeting as well as a meeting with the Attorney for the Village re: the airport. The Medicare Advantage Health Care Plan for Village retirees became effective on 5/1/21. Spoke of the new dugouts at Sertoma Field. The Village is in need of seasonal employees.

Attorney McKertich commented that he sent both the Telecommunications Law and the Solar Energy Law to the board for review. A decision will have to be made by the board. Spoke of adopting a law re: RPTL487, in which the State has exempted from taxation solar and wind energy facilities and other renewable energies. The Village can opt out of this exemption and apply the tax to those entities by adopting a Local Law. A decision will have to be made by the board.
