3. Mayor's Announcements

Attended a Chamber of commerce breakfast. Focus was on the problems we experience in New York State in bringing in and retaining businesses and residents! Found one big help is community events! We need people to gather and work together to help our economy and Village. Eileen and I went to talk to a staff member of Congresswoman Tenney's(in person). We told him some things we need in the Village like new garbage trucks and help with our aged water infrastructure. We have contacted her office many times, so we will see what develops now that we have. The Washington Avenue Revitalization project is progressing. We have the street scape ideas ready for the public, now we are working on the parking lot and ally way. Many people have expressed that security and safety are their main concern. Our police department is help us with our security camera selections. Congresswoman Lupardo has offered to help with the Avenue ones, and we will be seeking donations for the parking lot and ally way cameras. The Town of Chenango is now working with our swat team.

We still have brown water. Other municipalities have a special project fund fee they charge. If we raise rates, we will specify where the money will go. Our 15-million-dollar filter and the new well. Hunt engineering is researching grants for these projects to help with the costs.

We were finally able to take down the two dead trees at the library. This had been in the works since May. But as we were told, everything dies eventually. I want to thank the code department, street department, and both tree companies for helping us preserve safety. As well as the library for paying for this work to be done. Water had damaged the one tree so bad, that the whole middle of the trunk was rotted. I told the library to do whatever needed to be done to protect our Village residents from danger. I thought this would be done in May, but after getting a second tree company involved for additional information, they could not get a time for this work for a couple of months! In the meantime, a large branch fell during that bad windstorm and damaged the new library roof. This would have been a huge liability if the large branches fell on unsuspecting people who patronize the library. We were lucky it was only the roof that suffered. This brought to the attention of the library this must be done now. They were worried someone

could have been seriously hurt or killed. Safety of our citizens is our priority, and my responsibility as mayor.

Arbor Day event will now be at the library on October 9 from 1:00 to 3:00. Pm to plant a Norway spruce and an Oak tree to replace the dead trees taken down.

The homecoming parade is also on October 9 from 9:00 am to 12:00.

The light department announced there is a company who want to come to our Village. They believe it is a bit con facility. While they will use a lot of municipal electric, but we can charge them 3 times what our residents pay and can make money from this company.

Had a zoom meeting with Broome County executive Jason Garnar. His delta strain of COVID is more severe, easier to transmit, and spreads quickly. But as of now, there is no plan to mandate masks, demand vaccinations, or declare a state of emergency. Things may change if the situation changes.

Endicott Rotary is planning to clean up the weeds on the Avenue and maybe the parking lots if time permits. They hope this will inspire more people to get involved!

We desperately need school crossing guards. If interested, contact our human resources office. I enjoy informing our residents of all the accomplishments being made in the Village, and I feel our residents have a right to know what is going on. I did start posting a 'State of the Village' report on the Village web site. Then I went to posting on my Facebook page daily because I had so much to share. With so many projects demanding the attention of my secretary and myself, I find it hard to report as I wanted to. Dorner-Comments re: Noise at Huron campus, He also called Congresswoman Tenney's office to discuss the infrastructure and water problems and is expecting a call back from them. He posted a question to Mayor Jackson re: a notice being sent to the UESD re: the tobacco license and certain depts. And people being notified.

Konecny- The Endicott Rotary made a very nice donation to the Arch celebration. Apple Fest is coming along nicely. BAE has become a sponsor as well. Spoke with intern from Claudia Tenney's office re: infrastructure and broken water mains.

Trustee Warner asked on an update with Friday Coffee with the Mayor. Mayor Jackson stated that she is having private meetings and coming to her office. Mayor Jackson stated she sent the board an email in May informing them. Discussion went on re: the resolution that was passed in May. VOE Code and Street determined these were considered an emergency.

Trustee Dorner requested a report from the arborist certifying these trees were not healthy. He questioned the status of the Supervisor position. Attorney McKertich stated this should be discussed in Executive Session.

Burlingame- A reminder the GUSTO Festival and Fireworks is 8/27/21. He thanked the Little Italy coordinators for their efforts. The refuse committee is about ready to bring their proposal to the board. They are planning on keeping the 3 can limit as opposed to changing it to 4, at least for now due to unknown costs. A few things do need to still be worked out. He stated that he gets asked as to why the board debates so much during a public meeting, rather than behind closed doors. Trustee Burlingame stated that there is a NYS law called the Open Meetings Law which prohibits the board from holding these conversations from behind closed doors. Under the Law, the public has a right to attend meetings, listen to the debate and watch the decision making process. He made comments re: the tree removal at the Library. He strongly objects to the Mayor giving the authorization to remove the trees. He asked the Mayor if she intends to follow proper procedure in the future. Mayor Jackson stated that she intends as Mayor, to do whatever is needed to represent the people
